### Agenda 1 Confirmation of minutes of last AGM held on 23rd June 2022 at New Delhi

The minutes of the last Annual General Meeting which was held on 23<sup>rd</sup> June 2022 at New Delhi which was already circulated to the members presented to the house. Since there were no comments minutes were proposed to be passed by Mr. DS Solanki and Mr. R K Gupta seconded.

### Agenda 2 Annual Report of CFI for the year 2022-23

Mr. Maninder Pal Singh, Secretary-General appreciated and thanked all the State Associations/boards and all the stake holders for their contribution and hard work during the year in each and every event that was organized under the aegis of Cycling Federation of India.

### Agenda 3 To present the account of CFI for the year 2022-23+

### Agenda 5 To approve the National Calendar for the year 2023-24

Mr. Maninder Pal Singh, Secretary-General informed the house that one bid each for the National championships have been received and thus the same was allotted accordingly, which is as follows:

2023 National Track Cycling Championship will be organized by the Jharkhand Cycling Association and the tentative dates proposed are 23<sup>rd</sup> Nov to 27<sup>th</sup> Nov 2023.

2023 National Road Cycling Championship will be organized in Bijapur, Karnataka by the Karnataka Cycling Association and the tentative dates proposed are December 2023, specific dates will be discussed and further published on the website.

Mr. Raju Biradar, General-Secretary, Karnataka Cycling Association, thanked Cycling Federation of India to have allotted them the National Road Cycling Championships for the 2023, the then congratulated Mr. Pankaj Singh, President and ensured that all the rules and regulations as per the Union Cycliste Internationale, Asian Cycling Confederation and Cycling Federation of India will be followed during the said championships.

2023 National Mountain Bike Championships, will be organized in Kerala, which was earlier proposed to be held in October 2023, before the 2023 Asian Mountain Bike Championships which will be held in Kerala. But because of the busy schedule CFI requested to move the said event, which will now be held in August 2023, final dates will be published soon on the website.

### Agenda 6 To award the 2022 CFI Achievement Award

The Secretary-General informed the house that for a few years back CFI decided to honor two members with Merit award for their outstanding contribution towards the cycling.

V.N Singh, Assistant Secretary, then announced that the first award will be given to Late B.K Rout ji, who was General Secretary of Orissa Cycling Association, he had given 60 years of his life to the sports of cycling, who unfortunately expired a while back, but his contribution and hard work will always be remembered by the Cycling family.

The next award was given to Mrs. Minati Mohapatra, Arjun awardee, for her excellence in sports of cycling over the years.

The next award was for Mr. Parminder Singh Dhindsa, for his contribution towards the development of the cycling sports for over the decade.

The awards were presented by Mr. Pankaj Singh, President, Cycling Federation of India, Mr. Onkar Singh, Secretary-General, Asian Cycling Confederation, Mr. Manjit Singh GK, Sr. Vice President, Cycling Federation of India, Mr. Maninder Pal Singh, Secretary-General, Cycling Federation of India, Mr. Vimal Chaudhary, Vice President, Cycling Federation of India.

### Agenda 7 Any other matter with the permission of the chair.

Mr. Maninder Pal Singh, Secretary-General, informed the house that there are some mandatory Commissions to be formed and also need to be ratified by the General house, the house then unanimously resolved to give the powers of appointing the various commissions to the President in Consultation with the Secretary-General.

Mr. Rohit Sharma, General-Secretary, Himachal Pradesh Cycling Association, informed the house that all the members of their association has unanimously decided to restructure the organization due to some technical reasons and rename it as Himcycling Association, and had registered themselves under the Companies Act, as per the Indian Olympics Association, regarding which a letter had already been sent to the Cycling Federation of India dated 21<sup>st</sup> April 2023, he further asked the house to kindly consider the same.

Mr. Maninder Pal Singh, Secretary-General, with the permission of the chair addressed the request, he mentioned that the state association can be registered as the Trust, Society or the Company under the Company Act under Section 8, as per Indian Olympic Association resolution, he requests the house for the approval and the house unanimously approved the same.

As there was no other matter to discuss, the meeting was adjourned with a vote of thank to the chair.
