Para committee decision

Purpose:

This policy outlines the criteria for selecting athletes for Paralympics 2024 based on recent performances at the International competitions and Asian Cycling Championships.

Overview:

The selection policy aims to recognize outstanding athletic performance and ensure the representation of top athletes in Paralympics 2024. Considering the Recent results from International selection trials, Asian Cycling Championship and UCI Ranking will be a key factor in the selection process.

Eligibility Criteria:

1. Athletes must be in good standing with the Cycling Federation of India.
2. Athletes must meet the minimum performance standards set by the federation.
3. Selection will be based on recent selection trial results and the Asian Cycling Championship.
4. UCI Ranking

Selection Criteria Events and Dates:

1. Selection trials for International competition dated on 8 Mar 2024
2. 2nd Selection trials for Asian Cycling Championships date on 27 Apr 2024
3. UCI Ranking

Based on the above criteria and events following athletes have been selected for Paralympics 2024:

Note: Prashant Arkal has been selected for the Paralympic Games through a bipartite application process. This is a special allocation for athletes who do not qualify through standard procedures but


demonstrate potential for competition.


The Cycling Federation of India is committed to a fair and transparent selection process, ensuring that the best athletes represent the country in Paralympics 2024.
