

## **Regulations for organization of Masters Road Championships**

1. The license shall be considered if application is forwarded by the affiliated State unit/boards only.
2. A license shall be withdrawn on grounds who has been found guilty of misconduct/ found guilty of any violation of regulations of CFI or Anti- doping body.
3. The CFI will issue the license subject to payment of a license fee as per CFI regulations.
4. The validity of the license shall be from 1<sup>st</sup> Jan. to 31<sup>st</sup> Dec.
5. The commissaire panel and the PCP shall be appointed by the CFI and the PCP shall be responsible for the technical conduct of the event.
6. The organizers shall arrange suitable boarding/lodging arrangements for the PCP and 5 commissaire appointed by the CFI. The organizers shall bear the expenses equivalent to AC II tiers train fare as well as TA/DA as per CFI rules for PCP and 5 commissaire.
7. Organizer shall provide bib numbers, tags or other collaterals as per regulations of the CFI/UCI.
8. Organizer shall be responsible for sanitizing the route of the event and same shall be conveyed to the CFI at least 3 days prior to the event.
9. Organizer shall be responsible for providing the commissaires panel with all collaterals as per the list provided by CFI from time to time at least one day prior to the event.
10. The CFI reserve the right to cancel the event in case any discrepancy in the mentioned regulations/ requirements.
11. A license shall be withdrawn on grounds who has been found guilty of misconduct/ found guilty of any violation of regulations of CFI or Anti- doping body.
12. The CFI will issue the license subject to payment of a license fee as per CFI regulations.
13. The validity of the license shall be from 1<sup>st</sup> Jan. to 31<sup>st</sup> Dec.
14. The category of the event shall be as follows:

Men (ITT and MASS START)

35 years to 45 years

45 years to 55 years

55 Years & above

Women (ITT and MASS START)



- 35 years to 45 years
- 45 years to 55 years
- 55 years & above

15. Event specific regulations shall be provided by the CFI to the organizer.
16. The recognition to an event by the CFI or an event held under the aegis of the CFI shall in no manner be responsibility of the CFI and the organization shall lie with the organizer.
17. The Organizer will make the utmost efforts to abide by the duty of care and safely operate the Event as the administrator. Even in the case of an accident, the Organizer/CFI will not be legally responsible for damages or losses.
18. The Organizer/CFI may change the competition schedule and venues, and cancel, integrate or re adjust events, or the rules (including events and age categories) when there is an operational need.
19. The Organizer/CFI will not be liable for any damages or losses (including travel and accommodation charges) that may arise from such circumstances.
20. The Organizer/CFI will not be liable for any injury to body, damages road conditions, example rains, water clogging etc.
21. The Organizer/CFI will endeavor to provide exact information on the event and correct errors if any (including information provided by email, circular etc. in relation to the Event).
22. The Organizer/CFI may change the details of the rules, etc. at any time (including adding new contents) at its discretion.
23. Participation/ License may be withdrawn and or the rider may be debarred from competing in any event recognized by CFI if the rider is found guilty of the following:
  - 23.1 Failure to correctly register and/or sign on/ false information.
  - 23.2 Use of inappropriate or non-regulation cycle, clothing, or equipment.
  - 23.3 Prohibited/non regulation assistance, equipment exchange, refreshment.
  - 23.4 Continuing in an event after being withdrawn, or failure to complete a course.
  - 23.5 Disobeying an Official's instructions.
  - 23.6 Dangerous riding and/or compromising the safety of another Participant.
  - 23.7 Conspiring, cheating or collusion to pre-determine or alter a result/placing.
  - 23.8 Failure to attend official ceremonies Failure to attend official ceremonies in proper dress code.
  - 23.9 Breach of the CFI Code of Conduct.
  - 23.10 Conduct that may bring the sport into disrepute.
