Team India Para Cycling Selection Trials for 13th Asian Para Cycling Championship

We would like to inform you that the selection trials for the Indian Para Cycling team, for the upcoming international tournaments **13th Asian Para Cycling Championship – 7-16th Feb 2025 at Phitsanulok Province, Thailand**, will be conducted on **January 5th, 2025**. The trials will be held at the Service Road of ORR Medchal, Hyderabad, in collaboration with the Cycling Federation of India and Telangana Cycling Association.

Please note the following points for those who are interested in participating in the selection trials:

- 1) The selection will be based purely on merit, according to the predetermined timing/speed (MQS) set by CFI for each category as per the last rider's timing from the last World Championships or wherever you have received this time. Refer to Appendix A for MQS. **Participants who do not meet the MQS, will not be eligible for events.**
- 2) Top three positions of every category as per their MQS, **will be eligible to participate at their own cost (no cost to Government or Federation)**. In case there are less than or equal to 3 participants, then -1 rule will be applied, i.e. Top 2 in case of 3 participants, Top 1 in case of 2 participants.
- 3) This selection is in addition to those riders who have already secured qualifying points for upcoming.
- 4) Athletes training internationally will have to submit their international event result in the last one month. The timing from the event result will be considered for qualification.
- 5) The handcycle (H1 - H5) category selection is also being considered. However, those interested in handcycling trials are required to bring their own handcycle and must comply with UCI regulations.

- 7) The athletes are required to arrange their own accommodation.
- 8) The decision of the selection committee shall be final and binding to all.
